

# 2026 First State Community Bank, First State Insurance Agency, First State Financial Management - Sikeston Jaycee Bootheel Rodeo – Veterans Night VIP Experience

## Official Rules

1. **GENERAL. NO PURCHASE, PAYMENT OR OBLIGATION NECESSARY TO ENTER OR WIN.** The 2026 Sikeston Jaycee Bootheel Rodeo – Veterans Night VIP Experience begins March 1, 2026 at 12:01 a.m. Central Time (CT), and ends June 1, 2026 at 11:59 p.m. CT (the “Contest Period”). The Odds of winning will depend on the number of eligible entries received.
2. **ELIGIBILITY.** The Contest is open and offered only to natural persons who are legal residents of Missouri and are 21 years of age or older as of the date of entry, and have a Military ID. Members of the Board of Directors of First State Community Bank, employees who work in any capacity for First State Community Bank, First State Insurance Agency, or First State Financial Management (and their respective IRS dependents, immediate family members and individuals residing in their same household) are not eligible to participate. By participating, entrants agree to these Official Rules and the decisions of the Sponsor. Void where prohibited. Sponsor’s computer will be the official time-keeping device for the contest. The Contest is subject to all applicable federal, state and local laws and regulations. The Contest is open to First State Community Bank, First State Insurance Agency, and First State Financial Management customers and non-customers.
3. **HOW TO ENTER.**
  - a. **Online Entry Method.** During the Contest Period, consumers will fill out a form nominating an eligible entrant.
  - b. **Mail-In Alternative Entry Method.** During the Contest Period, nominations may hand print the name, address, city, state, ZIP Code, telephone number, and e-mail address, including contact information and military status, on a 3”X 5” card and mail the card in a hand-addressed, stamped envelope to Veterans Night VIP, First State Community Bank, Marketing, 201 E. Columbia Street, Farmington, MO 63640. Mailed entries must be postmarked by the “Mail-In Postmarked by Date” and received by the “Mail-in Received by Date” listed in the chart in Rule #4 to be eligible for the corresponding Drawings. Limit one entry per envelope. Mechanically reproduced, photocopied, illegible, incomplete, or inaccurate entries are automatically void.

4. **RANDOM DRAWING.** The Sponsor will conduct one random drawing on July 8th (each a “Drawing”) from all eligible entries timely received during the periods set forth in the table below. 50 winners will be selected with the option to bring a plus one, 21 years of age or older.

The decisions of the Sponsor are final and binding in all matters relating to the contest, including the Drawings. The eligible entrants selected (subject to verification of eligibility, the “Winners”) will be notified by phone, e-mail and/or U.S. Mail on or about two (2) business days following the Drawing. Winners must meet all eligibility requirements and, depending on the value of the prize, may be required to provide their Social Security number, and complete and to submit to Sponsor an Affidavit of Eligibility, and Publicity and Liability Release (where legal), each of which must be completed, signed and returned within seven days from date of issuance, or the prize will be forfeited and may be awarded to an alternate winner, time permitting.
